

## Welthungerhilfe\_ Beneficiary Privacy Notice & Explicit Consent

This privacy notice was prepared by **Deutsche Welthungerhilfe e.V. Turkey Representation Office ("WHH Turkey")** as data controller in accordance with Article 10 of the Turkish Law No. 6698 on the Protection of Personal Data ("Law") and the Communiqué on the Procedures and Principles of Fulfilling the Obligation to Inform.

For the purposes of (i) providing you with appropriate level of support to meet your needs according to your situation, and (ii) ensuring that social aid projects can be sustained in line with its purposes, the private and general personal data as types of Name-Surname, Identity-passport information, gender. nationality, marital status, education information, signature, health status, phone number, e-mail address, address information, bank account number which you share through your social aid applications and via forms that you fill in as a part of the social aid that you receive within the scope of social aid projects, will be recorded, stored, adopted, kept up to date and processed by WHH Turkey through automatic and/or nonautomatic means based on the legal grounds provided under Article 5/2 of the Law, which states that "the processing activity is necessary for establishment, use or protection of a right" and "the processing is mandatory for the data controller to be able to perform legal obligations", and can be transferred to real and legal persons permitted in the legislation, other authorized public institutions and organizations, judicial and administrative judicial authorities, law enforcement agencies,

Institutions and organizations, authorities and relevant ministry related to humanitarian aid activities, and humanitarian associations with the same purpose, and outsourced consultancy, technology companies in proportion with legal or service-related actual requirements.

WHH Turkey will be able to share some of your personal data and sensitive health data may be transferred to third parties, especially the parties associated with WHH Turkey. This processing and transfer activity will be carried out for the purpose of conducting emergency processes and is based on your explicit consent.

You are also informed that you can give up your explicit consent at any time.

You may submit your requests to WHH Turkey under Article 11 of the Law concerning the rights of the data subject in accordance with the Communiqué on the Procedures and Principles of Application to a Data Controller, which are;

- 1. To learn whether your personal data have been processed or not,
- 2. To request information as to processing if your data have been processed or not,
- 3. To learn the purpose of processing of the personal data and whether data are used in accordance with their purpose or not,
- 4. To know the third parties in the country or abroad to whom personal data have been transferred,

- 5. To request rectification in case personal data are processed incompletely or inaccurately,
- 6. To request deletion or destruction of personal data,
- 7. To request notification with regards to the processes of correction, deletion, and destruction to third parties to whom personal data have been transferred,
- 8. To object to occurrence of any result that is to your detriment by means of analysis of personal data exclusively through automated systems,
- 9. To request compensation for the damages in case the person incurs damages due to unlawful processing of personal data.

## Explicit consent regarding processing of sensitive data and cross-border transfer of personal data abroad:

I acknowledge that I have read in whole and understood "WHH TURKEY BENFICIARY PRIVACY NOTICE" and that I was adequately informed on the processing of my sensitive personal data and cross-border transfer of my personal data, including sensitive, by Deutsche Welthungerhilfe e.V. Turkey Representation Office ("WHH Turkey") in the scope of the Turkish Law No 6698 on the Protection of Personal Data ("Law") and that I will be able to withdraw my explicit consent anytime at my sole discretion without any limitations. I acknowledge that with my hereby explicit consent below, I am allowing my personal data to be stored, processed and transferred abroad limited to the purposes which are stated and for the maximum period necessary for the purposes or statutory limitation periods and I declare that I was informed by WHH Turkey in a way that does not give rise to any hesitation in this matter and that I have expressed my explicit consent in accordance with the Law.
